# DIAMOND DOG FOOD RECALL UPDATE

Diamond Pet Food Media Statement on FDA Investigation Findings  
02/01/2006

(Although this was an East Coast recall, at least 25 dogs died and numerous dogs were sickened, so we need to be aware of Aflatoxin Poisoning! ~Julie)

\*\*\*META, Mo. – Jan. 31, 2006 – Diamond Pet Foods cooperated fully with the U.S. Food and Drug Administration (FDA) during its investigation and supports the findings that were released today. Prior to the product recall, the company had stringent guidelines in place to test incoming shipments of corn for aflatoxin exposure. It was apparent by the FDA report that those guidelines were not followed. The company has taken the necessary actions to prevent these oversights from happening in the future. In addition, Diamond also has strengthened its testing procedures on incoming shipments of corn, and initiated final product testing as an additive step to its procedures. This additional step will provide an extra layer of protection prior to the bagging and shipping of products.

As a result of Diamond's cooperation with the FDA investigation and Diamond's implementation of additional testing, the United States Department of Agriculture has cleared the Gaston, S.C., facility for all product shipments, including export.

\*\*\*Meta, Mo. (Jan.12, 2006) – Diamond Pet Foods has seen media reports implying that our company knowingly distributed finished products containing toxic levels of aflatoxin. These reports are false and misleading. Prior to the initiation of our current voluntary recall, Diamond Pet Foods had no indication that any finished products manufactured by our Gaston, S.C. facility contained toxic levels of aflatoxin.

What we did know is there was a higher prevalence of aflatoxin in last year's corn crop. This information was communicated by many state Departments of Agriculture because of the weather conditions the corn crop experienced during its growing season. These conditions included severe drought followed by high moisture, which contributed to the growth of this fungus in the crop.

Diamond Pet Foods has stringent testing procedures to test loads of corn as they arrive. Last year, our company was rejecting one to two shipments of corn each week because testing revealed high levels of aflatoxin. However, even with stringent testing protocols, aflatoxin can exist in pockets and be missed.

## **Symptoms of potential illness in dogs may be difficult to discern, but include:**

- Loss of appetite**
- **Yellow whites of the eyes, yellow gums, yellow in the belly or areas where hair is very thin**
- **Severe, persistent vomiting combined with bloody diarrhea**
- **Discolored urine**
- **Fever**

Aflatoxins are naturally occurring toxins that are metabolic byproducts of fungi, *Aspergillus flavus*, and *Aspergillus parasiticus*, which grow on many food crops under favorable conditions.

Aflatoxins can invade the food supply at anytime during production, processing, transport or storage. Conditions that contribute to fungal growth and the production of aflatoxins are: a hot and humid climate, kernel moisture, favorable substrate characteristics, and factors that decrease the host plant's immunity (insect damage, poor fertilization, and drought).

Food and food crops most prone to contamination are corn and corn products, cottonseed, peanuts and peanut products, tree nuts (pistachio nuts, pecans, walnuts, Brazil nuts) and milk.

Aflatoxins are both teratogenic and carcinogenic, the liver is the principal organ affected in most species. Aflatoxin B1 is considered a carcinogen by the International Agency for Research on Cancer. The clinical syndrome of aflatoxicosis is characterized by abdominal pain, vomiting, pulmonary edema, convulsions, coma, liver damage, and death.

Aflatoxin contamination damages human health, animal health, the food supply, and world markets. Researchers are actively looking for methods to control aflatoxin contamination in susceptible crops. Classical plant disease prevention methods and routine technologies for controlling plant pathogens have generally been unsuccessful. Cooperative efforts to establish control strategies began in 1988 with the start of the annual Aflatoxin Elimination Workshop.
