## RCLRC MEMBERSHIP PONDERINGS

(Another Letter from the Editor)

Last month, the membership voted to post the RCLRC Membership Application on our Website. I have checked and almost every other club has a printable Membership Application, on their Website. This is a good thing, because RCLRC should be open to everyone interested in Labradors! There have been some concerns raised, though, that this also opens up the membership, to the public, more than it has been in the past. I have been researching how other clubs handle this issue. Most of the other clubs require a "Provisional/Associate Membership". They do not sponsor prospective members, until they have attended numerous club functions and/or participated in the club, for a set length of time. This allows time for everyone to get to know each other, before they are sponsored and voted on.

The Jersey Skylands LRC By-Laws call this time, an "Associate Membership".

"Associate members who have been active for at least one year at our events are welcome to seek sponsorship and apply for Full membership.

Committee Chairs are reminded to contact new members and get them involved in JSLRC activities."

LRC of the Potomac requires applicants must attend two club functions before applying for membership.

LRCGB~Each prospective member is required to attend at least 3 LRCGB meetings/events with their sponsor. Each membership is presented to the Club at the first meeting after being received for consideration, in accordance with the Constitution and By-laws of the Club.

SDLRC also has an Associate Membership.

“ASSOCIATE MEMBERSHIPS: "... Associate members may list completion of titles in the newsletter, attend meetings and events, compete for achievement awards and subscribe to the newsletter. Associate members may NOT vote, hold office, list litters in the newsletter or compete for annual awards.

REGULAR MEMBERSHIPS: In order to become a Regular member, an individual must attend two general membership meetings during the prior twelve months prior to submitting application, and submit a letter of recommendation with their application from two Regular members that are not of the same household. “

This idea is like "Limited Registration" ;o), so the membership can get to know the new people. Do they work well with others, are they ethical, are they a puppymill, etc, etc.??? RCLRC's current practice, is to print a new name in the Newsletter one month and vote them in the next , without getting to know them or giving them a chance to become involved. Is it wise to be voting on a person we have never met or heard of?

A change like this would require forming a Research Committee and RCLRC By-Law changes, but perhaps we should ponder a "Provisional/Associate Membership", such as other Labrador Clubs have, especially now that we have a Website. A set time requiring a new member to serve on a committee or attend several events, so we can all get to know each other, would be good for everyone. At the end of that provisional time, THEN they can they seek sponsorship, from all their new RCLRC friends and apply for a Full Membership. What do you think?
